ORDER

Sri K. Srinivasulu, Medchal-Malkajgiri District-500062 has filed a Complaint dated 28-08-2019 which was received by this Commission on 28-08-2019 for not getting the information sought by him from the PIO / O/o The Forest Divisional Officer, Forest Department, Nizamabad, Nizamabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 28-06-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

I submit that, through the reference cited I have requested Public Information Officer O/o Forest Divisional Officer, Nizamabad, requesting to kindly furnish certain information in respect to file no.230/2013/N2 under RTI act 2005. But no response from the Public Information Officer / Forest Divisional Officer, Nizamabad even after completing more than (2) years (Copy enclosed). Due to this inconvenience further action is held up at various levels.

In view of the above it is requested to benign Forest Divisional Officer/ Appellate authority Nizamabad kindly see to furnish the required information as soon.

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 16-12-2020.

The case is called on 16-12-2020. The Complainant is absent. The Public Information Officer / Sri K. Surender Raju, Superintendent, O/o The Forest Divisional Officer, Forest Department, Nizamabad, Nizamabad District is present.

The Public Information Officer submitted that vide letter Rc. No. 155/2018/RTI/F2 dated 03-08-2019, sought information was furnished to the complainant. He also submitted that the same was once again furnished to the complainant on 14-12-2020 under proper acknowledgement.

In view of the above, the complaint is closed.
