## **ORDER**

Smt G. Kamamma, Hyderabad-500096 has filed 2<sup>nd</sup> appeal dated 03-09-2019 which was received by this Commission on 03-09-2019 for not getting the information sought by her from the PIO / O/o The Tahsildar, Athmakur Mandal, Wanaparthy District and 1<sup>st</sup> Appellate Authority / O/o The Revenue Divisional Officer, Wanaparthy Division, Wanaparthy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 27-06-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in her application:

- 3) ఎలా ముఖ్యమంత్రి కార్యాలయం కు
- 4) ముఖ్యమంత్రి కార్యాలయం లోని కేసు నంబర్ డిక్లెయింట్ కు
- 5) పట్టణం గ్రామం లోని కేసు నంబర్ కేసు నంబర్
- 6) I-B-(ROR) కి ఎలా ముఖ్యమంత్రి కార్యాలయం లోని కేసు నంబర్

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, she filed 1<sup>st</sup> appeal dated 02-08-2019 before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by her.

The 1st Appellate Authority vide Notice Rc. No. I/963/2019, dated 08-08-2019 has informed the appellant and the Public Information Officer / O/o The Tahsildar, Athmakur Mandal, Wanaparthy District to appear before their office for hearing on 16-08-2019 at 03:30 PM along with relevant documents, the subsequent orders passed thereon is not known.

As the appellant did not get the information from the Public Information Officer and 1<sup>st</sup> Appellate Authority, she preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by her and also to arrange to furnish the information sought by her.

The Appeal was taken on file and the case was posted for hearing over phone on 10-09-2020.

On overview spread of COVID-19, the case was heard over phone on 10-09-2020. Both the parties were contacted on telephone. The representative of the Appellant and the Public Information Officer were heard.

The Public Information Officer submitted that vide letter dated 20-09-2019 sought information was furnished to the appellant.

The Appellant submitted that he has received the sought information from the Public Information Officer, but he was not satisfied with the information received. He also submitted that illegal mutation was processed in favour of his brother.

**The case was adjourned to 04-11-2020 for further enquiry.**

On 04-11-2020 the case is called. The representative of the Appellant is present. The Public Information Officer / Sri K. Nanda Kishore, Naib Tahsildar, O/o The Tahsildar, Athmakur Mandal, Wanaparthy District is present. The First Appellate Authority / O/o The Revenue Divisional Officer, Wanaparthy Division, Wanaparthy District is absent.

The representative of the Appellant submitted that irrelevant information was received from the Public Information Officer.

The Public Information Officer submitted that vide letter No. A/1200/2019 dated 20-09-2019 available and held information was furnished to the appellant.

The Commission directed the Public Information Officer to re-verify the plea of the appellant and to furnish correct and complete information to the appellant within one week from the date of receipt of this order and to report compliance to the Commission.

With the above direction, the case is closed.
