## **ORDER**

Smt. V. Aacharana, Khammam District-507002 has filed a Complaint dated 09-09-2019 which was received by this Commission on 09-09-2019 for not getting the information sought by her from the PIO / O/o The Forest Divisional Officer, Khammam Division, Khammam District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 18-06-2019 before the PIO / O/o The District Forest Officer, Khammam, Khammam District under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in her application annexed.

1. ఖమ్మం నగరంలో నవ్ కలెక్టర్ (ఆర్ డి ఓ) ఖమ్మం వారి కార్యాలయం ఎదురుగా అనగా నంజీవరెడ్డి భవన్ (కాంగ్రెసు పార్టీ ఆఫీస్) ప్రక్కన ఉన్న రెండు పాత/నిరుపయోగ/నిర్మాణము వ్యభవనాలు ప్రభుత్వానివేనా? తమరియొక్క అటవి శాఖవేనా? తెలువగలరు.
2. తమరి యొక్క అటి శాఖవే అయినట్లయితే అవి ఎప్పటి నుండి ఖాళీగా ఉన్నాయి.
3. వాటిని తమరి యొక్క శాఖ యొక్క ఏ వసులకు ఉపయోగించబోతున్నారో తెలువగలరు.
4. ఆ భవనాలకు సంబంధించిన పూర్తి వివరాల దస్త్రం నకలు మొత్తం ఇవ్వగలరు.

The Public Information Officer / O/o The District Forest Officer, Khammam, Khammam District vide letter Rc. No. 342/2019/S4 dated 21-06-2019, has transferred the application U/s.6(3) of the RTI Act to the Public Information Officer / O/o The Forest Divisional Officer, Khammam Division, Khammam District, as the sought information is available in their office.

As the Complainant did not receive the required information from the PIO, she preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by her.

The Complaint was taken on file and notices were issued to both the parties for hearing on 17-12-2020.

The case is called on 17-12-2020. The Complainant is absent. The Public Information Officer / Sri G. Sreedhar Rao, Superintendent, O/o The Forest Divisional Officer, Khammam Division, Khammam District is present.

The Public Information Officer submitted that vide letter No. 1778/2019/S3 dated 19-11-2019, sought information was furnished to the complainant and filed an affidavit to this effect.

The Commission further warns the Public Information Officer to strictly follow the provisions of the RTI Act, by timely furnishing the information hereafter with reference to Sec. 7(1) of the RTI Act or otherwise action will be taken under the provisions of Sec. 20 of the RTI Act.

With the above direction, the complaint is closed.
