ORDER

Sri Pulipati Prakash, Khammam District has filed 2nd appeal dated 09-09-2019 which was received by this Commission on 11-09-2019 for not getting the information sought by him from the PIO / O/o The Municipal Commissioner, Kothagudem Municipality, Bhadradri Kothagudem District and 1st Appellate Authority / O/o The Municipal Commissioner, Kothagudem Municipality, Bhadradri Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 28-05-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

2. వెంచర్ల లేఅవుట్ ప్లానింగ్ నిర్మాణముకు సంబంధించి మీరు ఇచ్చినటువంటి అనుమతి పత్రం, డిడి నకలు మరియు రిజిస్ట్రేషను నకలు మాకు తెలుపగలరు.
3. మీరు అనుమతి ఇచ్చిన అనుమతుల కన్నా ఎక్కువ అనుమతులు నిర్మించినప్పుడు మీరు వారిపై తీసికొనే చర్యలేమిటి? వాటికి సంబంధించిన నకలు సిడి ద్వారా ఇవ్వగలరు.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 24-08-2019 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 27-11-2020.

The case is called on 27-11-2020. The Appellant is absent. The Public Information Officer / Sri P. Ravindra Kumar, I/c Manager, O/o The Municipal Commissioner, Kothagudem Municipality, Bhadradi Kothagudem District is present. The First Appellate Authority / O/o The Municipal Commissioner, Kothagudem Municipality, Bhadradi Kothagudem District is absent.

The Public Information Officer submitted that vide letter No. G1/140/2019 dated 30-09-2019 sought information was furnished to the appellant.

Heard the Public Information Officer and perused the material papers available on record. The Commission observed that the Public Information Officer not furnished complete information for point No. 1. Thereby, the Commission directed the Public Information Officer to furnish information the figures has to how many applicants accorded permission under L.R.S., within one week from the date of receipt of this order and to report compliance to the Commission. The Appellant is directed to seek specific information in rest of the matter.

With the above directions, the appeal is closed.
