ORDER

Sri Kampally Murahari, Komaram Bheem Asifabad District-504296 has filed a Complaint dated 12-09-2019 which was received by this Commission on 14-09-2019 for not getting the information sought by him from the PIO / O/o The Tahsildar, Anthergaon Mandal, Peddapalli District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 01-08-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

Subject: Under RTI2005 Act., submit to Tahsildar, Anthargoam mandal of Peddapally Dist., to give the details for the Raithubandu Pathakam April 10th 2018, connected to K.Murahari, S/o. Late Yellaiah, R/o. Goliwada village of Anthargoam mandal, Peddally dist., Information -Reg

Dear Sir,

My name is Mr. Kampally Murahari, S/o. Late Yellaiah, Goliwada village. Here I am submitting the following query regarding misuse of my eligible checks as per Raithu Bandu pathakam.

- 1) As per Raithu bandu pathakam, i need to get the Checks for an amount of 15,200/- on each and every instalment. But I didn't received the checks for both First (April 10th 2018) and Second instalments. So I am politely requesting you to kindly look into this concern and please enquire and furnish the details about the money that who had taken and in which account the amount was deposited?
- 2) Therefore I request your honour kindly enquire into the matter and to furnish the required information to me at the earliest.

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 20-11-2020.

The case is called on 20-11-2020. The Complainant is absent. The Public Information Officer / O/o The Tahsildar, Anthergaon Mandal, Peddapalli District is absent. Sri D. Rajender Rao, Junior Assistant is present on behalf of the Public Information Officer.

The representative of the Public Information Officer submitted that sought information was furnished to the complainant.

Heard the Public Information Officer and perused the material papers available on record. The Commission observed that the Public Information Officer filed an affidavit having furnished information.

The Commission directs the Public Information Officer to furnish the details explained in his affidavit submitted to the Commission for delay in providing patta pass book to the complainant, within one week from the date of receipt of this order and to report compliance to the Commission. The Commission further warns the Public Information Officer that he should strictly follow the provisions of the RTI Act, by timely furnishing the information hereafter with reference to Sec. 7(1) of the RTI Act or otherwise action will be taken under the provisions of Sec. 20 of the RTI Act.

With the above direction, the complaint is closed.
