## ORDER

Smt. Ambala Vijaya Kumari, Khammam District-507170 has filed 2<sup>nd</sup> appeal dated 31-01-2019 which was received by this Commission on 31-01-2019 for not getting the information sought by her from the PIO / O/o The Tahsildar, Kusumanchi Mandal, Khammam District-507159 and 1<sup>st</sup> Appellate Authority / O/o The Revenue Divisional Officer, Khammam Division, Khammam District-507001.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 15-10-2018 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in her application:

Since the appellant did not receive the information from the Public Information Officer, she filed 1<sup>st</sup> appeal dated 27-11-2018 before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by her.

The 1st Appellate Authority has not responded to the appellant.

The Public Information Officer has given a reply to the appellant vide Memo. Rc. No. B/12/2019 dated 10-01-2019.

The appellant having not satisfied with the reply received from the Public Information Officer and non response from the 1<sup>st</sup> Appellate Authority, she preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by her and also to arrange to furnish the information sought by her.

The Appeal was taken on file and notices were issued to both the parties for hearing on 08-12-2020.

The case is called on 08-12-2020. The Appellant is absent. The Public Information Officer / Sri S. B. Srinivas, Deputy Tahsildar, O/o The Tahsildar, Kusumanchi Mandal, Khammam District is present. The First Appellate Authority / O/o The Revenue Divisional Officer, Khammam Division, Khammam District is absent.

The Public Information Officer submitted that vide letter Memo. No. B/12/2019 dated 10-01-2019 sought information was furnished to the appellant and filed an affidavit to the effect.

The Commission verified the material papers on record and found that the plea of the appellant is to issue a new Pattedar Pass Book for which the Public Information Officer sought Aadhar details for updation of eKYC. The plea of the appellant not attracts the provisions of Sec. 2(f) of the RTI Act, as it is a personal grievance. The Public Information Officer / Deputy Tahsildar, Kusumanchi Mandal, Khammam District assured to solve the grievance.

In view of the above, the appeal is closed.
