ORDER

Ms. Akula Bhavani, Hyderabad-500048 has filed a Complaint dated 02-11-2019 which was received by this Commission on 02-11-2019 for not getting the information sought by her from the PIO / O/o The Tahsildar, Vikarabad, Vikarabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 24-09-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in her application annexed.

30 రోజులలో నాకు పొందే ద్వారా కాక లేదా అలా మొక్క ఏకేల ద్వారా అందజేయ-
గలరని మనవి.

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing her application, she preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by her.

The Complaint was taken on file and the case was posted for hearing over phone on 09-07-2020.

On overview spread of COVID-19, the case was heard over phone on 09-07-2020. Both the parties were contacted on telephone. The Complainant and the Public Information Officer were heard.

The Public Information Officer submitted that vide letter No. B/RTI/38/2019 dated 20-03-2020 the sought information was furnished to the complainant.

The Complainant submitted that she has received a letter dated 20-03-2020 from the Public Information Officer and she was not satisfied with the information received.

Heard both the parties and perused the material papers available on record, the Commission observed that the complainant has not been supplied with required information by the Public Information Officer.

The Commission directs the Public Information Officer to re-verify the records with reference to the plea made by the complainant U/s. 6(1) of the RTI Act and to provide sought information free of cost to the complainant with reference to Sec. 7(6) of the Act, within two weeks from the date of receipt of this order and to report compliance.

The case was adjourned to 26-11-2020.

On 26-11-2020 the case is called. The Complainant is absent. The Public Information Officer / Sri G. Vijayender, Naib Tahsildar, O/o The Tahsildar, Vikarabad, Vikarabad District is present.

The Public Information Officer submitted that the sought information was furnished on 20-03-2020 and once again on 27-05-2020 and produced copies of the same before the Commission.

Since information was furnished, the complaint is closed.
