ORDER

Sri Mohammed Abdul Gaffar, Secunderabad-500006 has filed a Complaint dated 07-11-2019 which was received by this Commission on 07-11-2019 for not getting the information sought by him from the PIO / O/o The Director, State Archives and Research Institute, Tarnaka, Secunderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 26-09-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

Respected Sir,

I, the undersigned would like to submit this Appeal before your benign authority as under:

That I have submitted an application dated 23-07-2019 under the Right to information act to furnish certified copies of File No. 109/1334F and Sanad dated 17-03-1948 which required for my records purpose to protect our land.

Thereafter, I made several visits and representations to the concerned office, but as on this date I have not been furnished the required information.

I submit that, the concerned authorities, have adopted the policy of evading and avoiding to furnish the information as required under the Right to Information Act, and taking lame excuses for the best reasons known to the authorities concerned, due to which I am facing lot of hardship and untold misery and further it is very much difficult for me to visit the office number of times buy spending huge amount and wasting of my time.

I submit that, the above sought information is very crucial for me to protect my vested rights and interest, as such it is just and necessary to furnish me the certified copied of the same with regard to my property.

In the light of the above mentioned facts and circumstances, I request your benign authority to kindly look into the matter in a expeditious manner and render justice to me and pass necessary instructions / directions to furnish me the required information at an earlier possible to meet the ends of justice.

The Public Information Officer has given a reply to the complainant vide letter No. R1/2987/Sectt/2019, dated 21-10-2019.

The Complainant was not satisfied with a reply received from the PIO, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and the case was posted for hearing over phone due spread of COVID-19 Pandemic on 21-08-2020 and next on 02-11-2020, duly issuing notices to both parties for personal appearance.

The case is called on 02-11-2020. The Complainant is absent. The Public Information Officer / O/o The Director, State Archives and Research Institute, Tarnaka, Secunderabad is absent.

This case came up for hearing on 21-08-2020, the case was adjourned with a direction to furnish the sought information to the appellant.

Today both the complainant and the Public Information Officer found absent.

On Perusal of copies of documents available on record reveals that the complainant has not filed 6(1) application under RTI Act. But filed a grievance for which he has to approach the appropriate authority for redressal.

With the above observation, the complaint is closed.
