ORDER

Ms. Ruhinaz, Warangal Urban District-506001 has filed a Complaint dated 30-01-2020 which was received by this Commission on 31-01-2020 for not getting the information sought by her from the PIO / O/o The Director, Scheduled Castes Development Department, DSS Bhavan, Masabtank, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 11-03-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in her application annexed.

SUB : " The Following Information Sought under RTI ACT -2005. Request to Provide the Required Information " Req – Reg :

As the Subject Cited above I hereby Submit You that I Want the Following Information :

- 1). The File No alongwith Date through Which Mr. G.GATUMALLU, Dist SC Dev.Officer, Jangaon, Officiating had been Deputed/ Pramoted as H.M. Cum Deputy Warden and Posted at Social Welfare Boys Ashram School, Kothagudem,(V) Gudur Taluk, Warangal Rural.**
- 2) All the Copies of MR.G.GATUMALLU'S Deputation/Promotion Order through Which MR.G.GATUMALLU was Deputed/promoted as (Head Master)H.M. CUM DEPUTY WARDEN and Posted at Social Welfare Ashram School, Kothagudem,(V) Gudur Taluk, Warangal Rural.**

Hence I Request you to please Furnish the Said information As Soon as Possible.

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing her application, she preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by her.

The Complaint was taken on file and notices were issued to both the parties for hearing on 14-10-2020.

The case is called on 14-10-2020. The Complainant is absent. The Public Information Officer / O/o The Director, Scheduled Castes Development Department, DSS Bhavan, Masabtank, Hyderabad is absent. The Assistant Public Information Officer / Smt. J. Shylaja, Assistant Director is present on behalf of the Public Information Officer.

The Assistant Public Information Officer submitted that vide letter No. H1/1186/2019, dated 02-04-2019 the complainant was informed to approach the concerned District Authority in terms of GOI office Memorandum No. 10/2/2008-IR, dated 12-06-2008, which was already transferred U/s.6(3) of the RTI Act to the Public Information Officer / O/o The Deputy Director, Scheduled Castes Development Department, Warangal Urban. She also submitted that vide letter Rc. No. A1/114/2019, dated 08-05-2019 and 10-12-2019 sought information was furnished to the complainant.
