**ORDER**

Sri Akoju Sambaiah, Warangal Rural District-506314 has filed 2<sup>nd</sup> appeal dated 18-11-2019 which was received by this Commission on 18-11-2019 for not getting the information sought by him from the PIO-1 / O/o The Mandal Parishad Development Officer, Wardhannapet Mandal, Warangal Rural District-506313, PIO-2 / O/o The Mandal Panchayat Officer, Sangem Mandal, Warangal Rural District and 1<sup>st</sup> Appellate Authority / O/o The C.E.O., District Parishad Office, Warangal Rural District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 13-08-2019 before the PIO / O/o The District Panchayat Officer, Warangal Rural, Warangal Rural District under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 27-09-2019 before the 1<sup>st</sup> Appellate Authority / The District Revenue Officer, O/o The Collector and District Magistrate, Warangal Rural, Warangal Rural District u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1<sup>st</sup> Appellate Authority / The District Revenue Officer, O/o The Collector and District Magistrate, Warangal Rural, Warangal Rural District vide letter Rc. No. H1/1386/2019 dated 15-10-2019 has transferred the application U/s.6(3) of the RTI Act to the PIOs / O/o The C.E.O., District Parishad Office, Warangal Rural District and O/o The Mandal Parishad Development Officer, Wardhannapet Mandal, Warangal Rural District to furnish the information directly to the appellant under intimation to their office.

The 1<sup>st</sup> Appellate Authority / O/o The District Panchayat Officer, Warangal Rural, Warangal Rural District vide Memo. Rc. No. 93/A5/2019, dated 04-10-2019 has requested the Public Information Officer / O/o The Mandal Panchayat Officer, Sangem Mandal, Warangal Rural District to furnish the information directly to the appellant under intimation to their office.

The appellant having not received the information from the Public Information Officers and 1<sup>st</sup> Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 20-10-2020.

The case is called on 20-10-2020. The Appellant is absent. The Public Information Officer-1 / Smt. T. Rajya Laxmi, Mandal Parishad Development Officer, O/o The Mandal Parishad Development Officer, Wardhannapet Mandal, Warangal Rural District is present. The Public Information Officer-2 / Sri C. Chetan Kumar, Mandal Panchayat Officer O/o The Mandal Panchayat Officer, Sangem Mandal, Warangal Rural District is present. The First Appellate Authority / O/o The C.E.O., District Parishad Office, Warangal Rural District is absent.

The Public Information Officer submitted vide letter No. A/153/RTI-2005/2020, dated 19-10-2020 that partly information was furnished to the appellant and requested time to provide left over information.

The First Appellate Authority submitted that she joined recently and sought time for furnishing the information.

Heard the Public Information Officer and perused the material papers available on record. The Commission observed that the Public Information Officer has not furnished complete information to the appellant.

The Commission directed the Public Information Officer to furnish the sought information to the appellant, within one week from the date of receipt of this order and to report compliance to the Commission.

With the above direction, the appeal is closed.
