## **ORDER**

Sri N. Praveen, Warangal Urban District-506370 has filed 2<sup>nd</sup> appeal dated 19-11-2019 which was received by this Commission on 22-11-2019 for not getting the information sought by him from the PIO / O/o The District Educational Officer, Hanamkonda, Warangal Urban District-506002 and 1<sup>st</sup> Appellate Authority / O/o The District Educational Officer, Hanamkonda, Warangal Urban District-506002.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 07-08-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

1. ప్రైవేటు స్కూల్స్ కి అనుబంధంగా, ప్రైవేటు స్కూల్స్ వారు విద్యార్థుల కోసం హాస్టల్ ను నిర్వహించుచున్నారు. ఇట్టి హాస్టల్ ని నిర్వహించుకొనుటకు కావలసిన నియమ నిబంధనలు మరియు ప్రభుత్వం నుండి పొందవలసిన అనుమతుల సమాచారం ఇవ్వగలరు.
2. ప్రైవేటు కోచింగ్ సెంటర్స్, అకాడమీలు, ఎడ్యు సెంటర్ ప్రైవేటు లిమిటెడ్ ఇంకా ఇతర విధములుగా ప్రైవేటు కోచింగ్ నిర్వహించుకొనుటకు వారు పాటించవలసిన నియమ నిబంధనలు మరియు ప్రభుత్వం తరుపున పొందవలసిన అనుమతుల సమాచారం ఇవ్వగలరు.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 15-09-2019 before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 18-11-2020.

The case is called on 18-11-2020. The Appellant is absent. The Public Information Officer / O/o The District Educational Officer, Hanamkonda, Warangal Urban District is absent. The First Appellate Authority / O/o The District Educational Officer, Hanamkonda, Warangal Urban District is absent.

Both the parties are absent.

The Commission observed that on receipt of preliminary notice sent by Telangana State Information Commission dated 02-12-2019, the Public Information Officer vide letter No. 5972/A3/RTI/B1/2019 dated 16-12-2019, a reply was furnished to the appellant, but the copy of G.O.No.200 dated 06-08-1992 referred to point No. 2 appeals to be not sent.

The Commission directs the Public Information Officer to furnish the same to the appellant within one week from the date of receipt of this order and to report compliance to the Commission.

The Commission warns the Public Information Officer to strictly follow the provisions of the RTI Act, by timely furnishing the information hereafter with reference to Sec. 7(1) of the RTI Act or otherwise action will be taken under the provisions of Sec. 20 of the RTI Act.

With the above direction, the appeal is closed.
