ORDER

Sri T. Nagaraju Gupta, Hyderabad-500053 has filed a Complaint dated 25-11-2019 which was received by this Commission on 25-11-2019 for not getting the information sought by him from the PIO / O/o The Tahsildar, Yadagirigutta, Yadadri Bhuvanagiri District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 30-07-2019 before the PIO / O/o The Revenue Divisional Officer, Bhuvanagiri Division, Yadadri Bhuvanagiri District under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

The Public Information Officer / O/o The Revenue Divisional Officer, Bhuvanagiri Division, Yadadri Bhuvanagiri District has transferred the application U/s. 6(3) of the RTI Act vide letter No. E/RTI/1627/2019, dated 16-08-2019 to the Public Information Officer / O/o The Tahsildar, Yadagirigutta, Yadadri Bhuvanagiri District to furnish the information directly to the complainant under intimation to their office.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and the case was posted for hearing over phone on 25-08-2020.

On overview spread of COVID-19, the case was heard over phone on 25-08-2020 and adjourned to 25-11-2020 with a direction to the Public Information Officer to furnish the sought information to the complainant within two days from the date of receipt of this order and to report compliance to the Commission. The Commission warned the Public Information Officer that hereafter if he failed to furnish the information in time as per the provisions of Sec. 7(1), further action will be initiated as per the provisions of Sec. 20 of the Act.

On 25-11-2020 the case is called. The Complainant is absent. The Public Information Officer / O/o The Tahsildar, Yadagirigutta, Yadadri Bhuvanagiri District is absent. The Assistant Public Information Officer / Smt. G. Suguna, Senior Assistant is present on behalf of the Public Information Officer.

The Assistant Public Information Officer submitted that vide letter No. N/02/2020 dated 24-11-2020, sought information was furnished to the complainant through RPAD.

The Public Information Officer is directed to be prompt, by timely furnishing the information hereafter with reference to Sec. 7(1) of the RTI Act or otherwise action will be taken under the provisions of Sec. 20 of the RTI Act.

With the above direction, the complaint is closed.
