ORDER

Sri Ambala Ramesh Babu, Khammam District-507170 has filed 2nd appeal dated 07-02-2019 which was received by this Commission on 07-02-2019 for not getting the information sought by him from the PIO / O/o The Tahsildar, Kusumanchi Mandal, Khammam District-507159 and 1st Appellate Authority / O/o The Revenue Divisional Officer, Khammam Division, Khammam District-507001.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 11-10-2018 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 27-12-2018 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 08-12-2020.

The case is called on 08-12-2020. The Appellant is absent. The Public Information Officer / Sri S. B. Srinivas, Deputy Tahsildar, O/o The Tahsildar, Kusumanchi Mandal, Khammam District is present. The First Appellate Authority / O/o The Revenue Divisional Officer, Khammam Division, Khammam District is absent.

The Public Information Officer put forth that the sought information by the appellant could not be furnished due to unforeseen reasons and sought fifteen days time to furnish the information and filed an affidavit to the effect.

The Commission verified the material papers on record and allowed two weeks time to the Public Information Officer with a direction to furnish the information to the appellant, failing which the Commission will take action against the Public Information Officer under the provisions of Sec. 20 of the RTI Act.

With the above direction, the appeal is closed.
