## **ORDER**

Sri Vipparla Ramesh Babu, Khammam District-507002 has filed 2<sup>nd</sup> appeal dated 09-02-2019 which was received by this Commission on 11-02-2019 for not getting the information sought by him from the PIO / O/o The Tahsildar, Khammam Urban Mandal, Khammam District and 1<sup>st</sup> Appellate Authority / O/o The Revenue Divisional Officer, Khammam Division, Khammam District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 13-08-2018 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 12-11-2018 before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 08-12-2020.

The case is called on 08-12-2020. The Appellant is absent. The Public Information Officer / Sri T. Suresh, Naib Tahsildar, O/o The Tahsildar, Khammam Urban Mandal, Khammam District is present. The First Appellate Authority / O/o The Revenue Divisional Officer, Khammam Division, Khammam District is absent.

The Public Information Officer submitted that the sought information was furnished to the appellant vide letter RTI No. 153/2018, dated 12-03-2019 and filed a copy of the letter along with an affidavit to the effect.

The Commission verified the material papers available on record and found that the reply/information stated to be sent to the appellant stating that the concerned files are not received in their office from erstwhile Khammam Rural Mandal, thereby they are unable to provide the information. The Commission took serious view of the reply given. "Information" means providing the available and held information with reference to Sec. 2(f) of the RTI Act, but informing that the records are not available does not mean that the information is furnished.

In the circumstances of the case the Commission directs the Public Information Officer to transfer the application received U/s. 6(1) of the RTI Act to the concerned Public Information Officer/Public Authority U/s.6(3) of the RTI Act, with who the record is available for furnishing the information or to collect the records from the concerned public authority on the point of jurisdiction and to furnish the information sought within (7) days from the date of receipt of this order and to report compliance to the Commission.

With the above direction, the appeal is closed.
