ORDER

Sri Lakkineni Suryanarayana, Khammam District-507002 has filed 2nd appeal dated 09-02-2019 which was received by this Commission on 11-02-2019 for not getting the information sought by him from the PIO / O/o The Tahsildar, Kalluru Mandal, Khammam District and 1st Appellate Authority / O/o The Revenue Divisional Officer, Kalluru Division, Khammam District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 07-09-2018 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

ఇవ్వబడిన తొడిమి వరముల తలయిచ్చేయమని ఇవ్వగలములకు (పాప పున్దిం మరియు
తొలి చూపుట ఈ తలయిచ్చేయమని ఇవ్వగలములకు తొలి చూపుట గాన
తొలి యిచ్చుండున వారి సమర్థించుటకై తొలి వరములకు తలయిచ్చేయ

తొలి చూపుట సమర్థించుటకై తలయిచ్చేయమని ఇవ్వగలములకు తొలి చూపుట గాన

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 09-10-2018 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The Public Information Officer has given a reply to the appellant vide letter Memo. No. RTI/A/53/2018 dated 06-10-2018.

The 1st Appellate Authority has responded and called the appellant and the Public Information Officer for hearings and disposed the case vide letter Rc. No. C/637/2018 dated 31-12-2018, thereof furnishing a copy of information submitted by the Public Information Officer.

The appellant having not satisfied with the information received from the Public Information Officer and 1st Appellate Authority, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 08-12-2020.

The case is called on 08-12-2020. The Appellant is absent. The Public Information Officer / O/o The Tahsildar, Kalluru Mandal, Khammam District is absent. The First Appellate Authority / O/o The Revenue Divisional Officer, Kalluru Division, Khammam District is absent.

Both the parties are absent.

The Commission verified the material papers available on record and found that the appellant sought information with regard to date of issue of Pattedar Pass Book No. 215131 on Khata No. 38 concerning survey No. 144, 145 of Laxmipura Village, Kalluru Mandal.

The Public Information Officer vide Memo. No. RTI/A/53/2018 dated 06-10-2018, informed the appellant that the Pass Book issued during 1996, and there is no record found as to actually on which date the Pass Book was issued.

In the circumstances the Commission is of the view that the Public Information Officer has furnished the available and held information to the appellant, **the appeal is closed.**
