## **ORDER**

Smt. D. Vijaya Laxmi, Yadadri Bhuvanagiri District-508112 has filed a Complaint dated 06-02-2020 which was received by this Commission on 07-02-2020 for not getting the information sought by her from the PIO / O/o The Metropolitan Commissioner, Hyderabad Metropolitan Development Authority, Block-B, HMDA Complex, Tarnaka, Secunderabad-500017.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 27-08-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in her application annexed.

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing her application, she preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by her.

The Complaint was taken on file and notices were issued to both the parties for hearing on 30-09-2020 and on 07-12-2020.

The case was called on 30-09-2020. The representative of the Complainant / Sri D. Praveen was present. The Public Information Officer / Sri K. Gangadhar, Planning Officer, O/o The Metropolitan Commissioner, Hyderabad Metropolitan Development Authority, Block-B, HMDA Complex, Tarnaka, Secunderabad was present.

The Public Information Officer submitted that vide letter File No. 831/RTI/PLG/HMDA/2019, dated 26-09-2019 sought information was furnished to the complainant through RPAD.

The representative of the Appellant submitted that he did not receive complete information from the Public Information Officer.

The Commission directed the Public Information Officer to re-verify the records and furnish complete information to the complainant within a week from the date of receipt of this order.

With the above direction, the case was adjourned to 07-12-2020.

The case is lastly heard on 30-09-2020, and adjourned for non supply of complete information by the Public Information Officer. The case is again called on 07-12-2020, by issuing prior intimation to the parties.

On 30-09-2020 on behalf of the appellant Sri D. Praveen, husband of the appellant is present and put forth that the sought information was not furnished till date.

The Public Information Officer / O/o The Metropolitan Commissioner, Hyderabad Metropolitan Development Authority, Block-B, HMDA Complex, Tarnaka, Secunderabad called absent.

The Commission verified the material papers on record and found that even after issue of specific orders dated 30-09-2020 the Public Information Officer failed to furnish the sought information to the appellant.

**In the circumstances of the case the Commission further directs to issue Show Cause Notice to all the PIOs who worked during the period from 27-08-2019 to 07-12-2020 for not furnishing the information as per the provision of Sec. 7(1) of the RTI Act and even till 07-12-2020 calling for their explanation as to why action should not be taken against them as per Sec. 20 of the RTI Act and to explain the reasons for failure to furnish the information to the complainant and to appear before the Commission on 28-01-2021 duly furnishing the information to the complainant to hear this case (which will be dealt separately).**

**This case is disposed accordingly.**
