ORDER

Sri Dhadi Sadaiah, Peddapalli District has filed 2nd appeal dated 11-02-2019 which was received by this Commission on 13-02-2019 for not getting the information sought by him from the PIO / O/o The Panchayat Secretary, Mandal Praja Parishad, Dongaturthi Village, Dharmaram Mandal, Peddapalli District and 1st Appellate Authority / O/o The Mandal Parishad Development Officer, Dharmaram Mandal, Peddapalli District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 27-10-2018 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

అన్ని పనులు పూర్తి చేసినట్లు. (5) మునుగువడ్డ అన్ని మంజురు కుసునకి జియోక్రకాస్టె
కాగితాలు మరియు పూర్తిచేసిన పత్రాల సహా ఇచ్చినట్లు. వివేకానందం అనే చెట్ల బుట్టల జియోక్రకాస్టె
కాగితాలు కేసు కమీషన్ నివేదనలు, తేది: 15-12-2016 నుండి మీరు ఇచ్చే తేదీ వరకు పూర్తి
చేయగలగినట్లు నాకు గ్రామీణులకు ఉపయోగపడే వున్నట్లు.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 15-12-2018 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant

As the appellant did not get the information from the Public Information Officer and non response from the 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 15-12-2020.
