## ORDER

Sri I. Nageswara Rao, Khammam District-507302 has filed a Complaint dated 13-02-2019 which was received by this Commission on 14-02-2019 for not getting the information sought by him from the PIO / O/o The Commissioner, Panchayat Raj and Rural Employment, Urdu Hall Lane, Himayatnagar, Hyderabad-500029.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 20-12-2018 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

① ఖచ్చితం జిల్లా, పెనుబల్లి మండలం 05/2018 నుండి 11/2018 వరకు ఎంతమంది, తండ్రియారు, వాళ్ళు ఏ కారణాల వల్ల తండ్రియారు, ప్రేమకాండేని సంబంధించిన వారలపై విచారణ జరిపి, సమాచారం ప్రకటితం చేయండి.

② ఖచ్చితం జిల్లా, పెనుబల్లి మండలం మొత్తం పిల్లలు, పుళ్ళెళ్ళు, పిల్లలు, తండ్రి పిల్లలు, physically handicapped పిల్లలు, బంటరి మహిళలు పిల్లలు, ఇప్పటి ఎంతమందికి పిల్లలు ఉన్నారో. వారి తండ్రి పేర్లు తెలియజేయండి.

③ ఖచ్చితం జిల్లా, పెనుబల్లి మండలం పిల్లలు తండ్రి తండ్రి, (పుళ్ళెళ్ళు, తండ్రి, phc, బంటరి మహిళ) వారిని ఏ కారణాల వల్ల పెంజింగిని ఉన్నారో, ఎంతమంది పెంజింగిని ఉన్నారో వారి పేర్లు ప్రకటితం చేయండి.

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 10-12-2020.

The case is called on 10-12-2020. The Complainant is absent. The Public Information Officer / O/o The Commissioner, Panchayat Raj and Rural Employment, Urdu Hall Lane, Himayatnagar, Hyderabad is absent.

Sri Mujeebur Rahman Khan, D.D.O., O/o The C.E.O., Society for Elimination of Rural Poverty, Hyderabad is present and submitted that the information sought was furnished by his predecessor. He requested time to furnish the same.

The Commission verified the material papers available on record and found that partly information was furnished by the then Public Information Officer to the complainant vide letter No. A3/85/RTI/2019 dated 14-03-2019 and the same was dispatched on 27-03-2019 to the complainant, with a request to pay Rs. 330/- to furnish complete information.

The Commission observed that a reply sent to the complainant dispatched on 27-03-2019 whereas the application filed U/s. 6(1) of the RTI Act received by the Public Information Officer on 20-12-2018 which is much beyond the time limit prescribed U/s. 7(1) of the RTI Act.

Hence, the Commission directs the Public Information Officer to furnish remaining information to the complainant free of cost with reference to Sec. 7(6) of the RTI Act within two weeks from the date of receipt of this order and to report compliance.

The Commission warns the Public Information Officer to strictly follow the provisions of the RTI Act by timely furnishing the information hereafter with reference to Sec. 7(1) of the RTI Act or otherwise action will be initiated against the Public Information Officer under the provisions of Sec. 20 of the RTI Act.

With the above direction, the complaint is closed.
