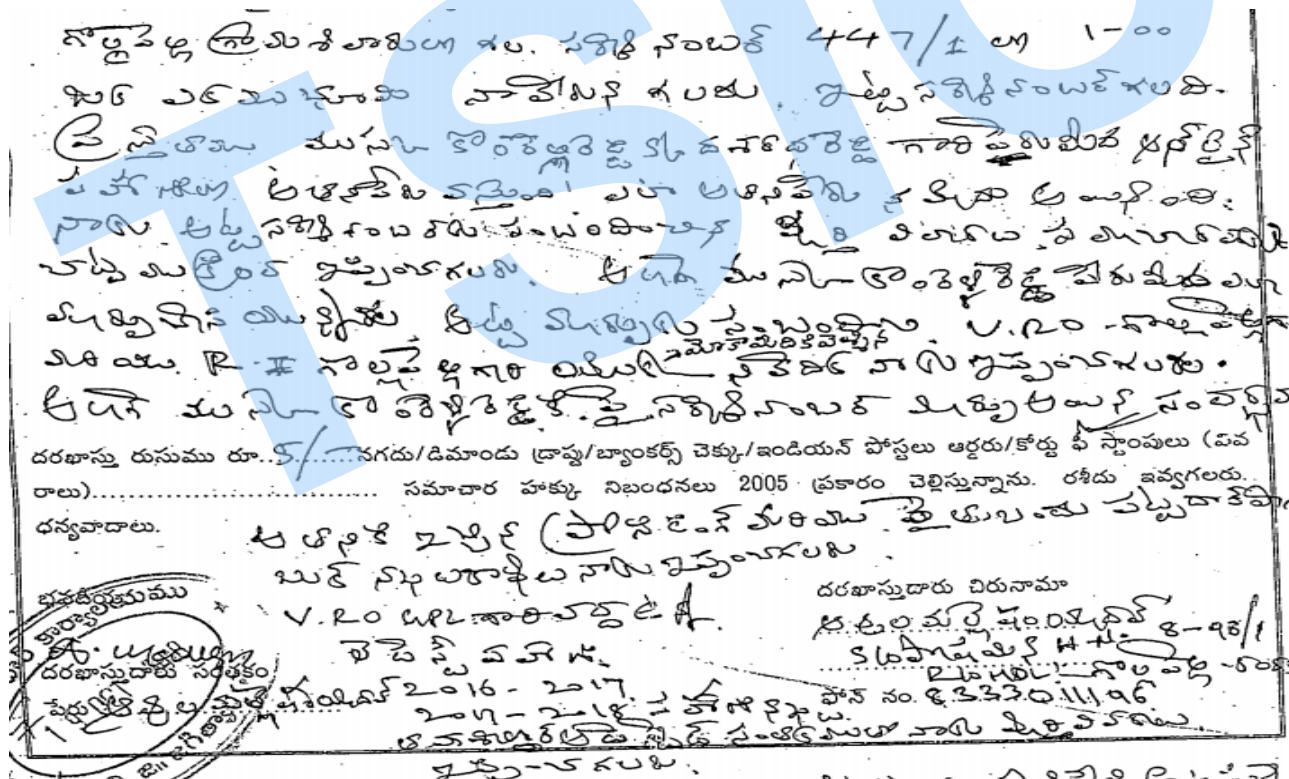

## ORDER

Sri Avula Mallesham Yadav, Jagtial District-505532 has filed 2<sup>nd</sup> appeal dated 18-02-2019 which was received by this Commission on 20-02-2019 for not getting the information sought by him from the PIO / O/o The Tahsildar, Gollapalli Mandal, Jagtial District and 1<sup>st</sup> Appellate Authority / O/o The Revenue Divisional Officer, Jagtial Division, Jagtial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 20-10-2018 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:



The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 19-11-2018 before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 09-12-2020.

The case is called on 09-12-2020. The Appellant is absent. The Public Information Officer / Sri Khaja Sami Ahmed, Naib Tahsildar, O/o The Tahsildar, Gollapalli Mandal, Jagtial District is present. The First Appellate Authority / O/o The Revenue Divisional Officer, Jagtial Division, Jagtial District is absent.

The Public Information Officer submitted that sought information was furnished to the appellant vide letter No. B/370/2018 dated 06-03-2019 by RPAD.

Heard the Public Information Officer and perused the material papers available on record. The Commission observed that there is no proof of having sent the above information to the appellant. The Commission directed the Public Information Officer to furnish once again the sought information to the appellant, within a week's time from the date of receipt of this order and to report compliance to the Commission.

With the above direction, the appeal is closed.
