ORDER

Sri Sk. Mansoor, Khammam District has filed 2nd appeal dated 19-02-2019 which was received by this Commission on 21-02-2019 for not getting the information sought by him from the PIO / O/o The Tahsildar, Nelakondapally Mandal, Khammam District-507160 and 1st Appellate Authority / O/o The Revenue Divisional Officer, Khammam Division, Khammam District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 26-10-2018 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 07-01-2019 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 08-12-2020.

The case is called on 08-12-2020. The Appellant is present. The Public Information Officer / Sri L. Veerabhadram, Naib Tahsildar, O/o The Tahsildar, Nelakondapally Mandal, Khammam District is present. The First Appellate Authority / O/o The Revenue Divisional Officer, Khammam Division, Khammam District is absent.

The Public Information Officer submitted that the sought information was furnished to the appellant vide letter No. B/365/2020 dated 07-12-2020, and filed an affidavit to the effect.

The Commission verified the material papers available on record and found that the sought information was furnished by the Public Information Officer vide letter dated 07-12-2020 under proper acknowledgment, but with abnormal delay.

In the circumstance of the case, **the Commission closed the case** with a direction to the Public Information Officer to strictly follow the provisions of Sec. 7(1) of the RTI Act hereafter or else further action as deemed fit will be taken against with reference to Sec. 20 of the RTI Act.
