ORDER

Sri Keshetti Venkateswarlu, Warangal Rural District-506164 has filed 2nd appeal dated 24-02-2020 which was received by this Commission on 26-02-2020 for not getting the information sought by him from the PIO / O/o The Head Master, ZPHS Rayaparthi, Nadikuda Mandal, Warangal Rural District-506391 and 1st Appellate Authority / O/o The Head Master, ZPHS Rayaparthi, Nadikuda Mandal, Warangal Rural District-506391.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 30-12-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

①. Z.P.S రాయపల్లి (పి) 2018-19 విద్యా సంవత్సరానికి సూచించే వచ్చిన ఖాతాలు, ఖర్చుల వివరాల జాబితా.

② Z.P.S రాయపల్లి (పి) సూచించే కాంప్లెక్స్ 2018-19 విద్యా సంవత్సరానికి వచ్చిన ఖాతాలు, సమావేశ వివరాలు, ఉపాధ్యక్షులు హాజరు, చేసిన ఖాతాసంఖ్యలు జాబితా అట్టిప్రకారం కావాలను సమాచార హక్కు చట్టం క్రింద అందజేయగలరు.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 10-02-2020 before the 1st Appellate Authority / O/o The District Education Officer, Warangal Rural, Warangal Rural District u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority / O/o The District Education Officer, Warangal Rural, Warangal Rural District vide letter Rc. No. 467/B4/2020 dated 13-02-2020 has transferred the application U/s.6(3) of the RTI Act to the Public Information Officer / O/o The Head Master, ZPHS Rayaparthi, Nadikuda Mandal, Warangal Rural District to furnish the information directly to the appellant under intimation to their office.

As the appellant did not get the information from the Public Information Officer and 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 20-11-2020.

The case is called on 20-11-2020. The Appellant is present. The Public Information Officer / O/o The Head Master, ZPHS Rayaparthi, Nadikuda Mandal, Warangal Rural District is absent. The First Appellate Authority / O/o The Head Master, ZPHS Rayaparthi, Nadikuda Mandal, Warangal Rural District is absent.

The Appellant submitted that he has received part information from the Public Information Officer, and requested to furnish complete information.

The Commission directs the Public Information Officer to re-verify the application filed U/s.6(1) of the Act and to furnish complete information to the appellant within one week from the date of receipt of this order and to report compliance to the Commission.

The Commission warns the Public Information Officer that they should strictly follow the provisions of the RTI Act, by timely furnishing the information hereafter with reference to Sec. 7(1) of the RTI Act or otherwise action will be taken under the provisions of Sec. 20 of the RTI Act.

With the above direction, the appeal is closed.
