ORDER

Sri Gurram Malla Reddy, Rajanna Siricilla District has filed a Complaint dated 25-03-2019 which was received by this Commission on 25-03-2019 for not getting the information sought by him from the PIO / O/o The Mandal Parishad Development Officer, Siricilla Mandal, Rajanna Siricilla District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 12-02-2019 before the PIO / The District Revenue Officer, O/o The Collector and District Magistrate, Siricilla, Rajanna Siricilla District under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

The Public Information Officer / The District Revenue Officer, O/o The Collector and District Magistrate, Siricilla, Rajanna Siricilla District vide letter No. H/247/2019 dated 23-02-2019, has transferred the application U/s.6(3) of the RTI Act to the Public Information Officer / O/o The Mandal Parishad Development Officer, Siricilla Mandal, Rajanna Siricilla District to furnish the information directly to the complainant under intimation to their office. Further the Public Information Officer / O/o The Mandal Parishad Development Officer, Siricilla Mandal, Rajanna Siricilla District has given a reply to the complainant vide letter No. AEE/32/2019 dated 02-03-2019.

The Complainant having not satisfied with the reply received from the PIO, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 27-11-2020.

The case is called on 27-11-2020. The Complainant is absent. The Public Information Officer / O/o The Mandal Parishad Development Officer, Siricilla Mandal, Rajanna Siricilla District is absent.
