## **ORDER**

Sri Gurram Mallareddy, Rajanna Siricilla District has filed a Complaint dated 25-03-2019 which was received by this Commission on 25-03-2019 for not getting the information sought by him from the PIO / O/o The Revenue Divisional Officer, Siricilla Division, Rajanna Siricilla District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 31-01-2019 before the PIO / The District Revenue Officer, O/o The Collector and District Magistrate, Rajanna Siricilla, Rajanna Siricilla District under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

The Public Information Officer / The District Revenue Officer, O/o The Collector and District Magistrate, Rajanna Siricilla, Rajanna Siricilla District vide letter No. H/213/2019, dated 02-02-2019 has transferred the application U/s.6(3) of the RTI Act to the Public Information Officer / O/o The Revenue Divisional Officer, Siricilla Division, Rajanna Siricilla District to furnish the information directly to the complainant under intimation to their office.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 02-11-2020.

The case is called on 02-11-2020. The Complainant is present. The Public Information Officer / O/o The Revenue Divisional Officer, Siricilla Division, Rajanna Siricilla District is absent.

The Complainant submitted that he did not receive the sought information from the Public Information Officer.

The Commission directs the Public Information Officer to furnish the sought information to the complainant within one week from the date of receipt of this order and to report compliance to the Commission.

The Commission warned the Public Information Officer that he should strictly follow the provisions of the RTI Act, by timely furnishing the information hereafter with reference to Sec. 7(1) of the RTI Act or otherwise action will be taken under the provisions of Sec. 20 of the RTI Act.
