The Complaint was taken on file and notices were issued to both the parties for hearing on 15-12-2020.

The case is called on 15-12-2020. The Complainant is present. The Public Information Officer / O/o The Revenue Divisional Officer, Siricilla Division, Rajanna Siricilla District is absent. Sri D. Maruthi Reddy, Naib Tahsildar is present on behalf of the Public Information Officer.
