ORDER

Sri Naspuri Shanthaiah, Peddapalli District-505187 has filed a Complaint dated 26-03-2019 which was received by this Commission on 28-03-2019 for not getting the information sought by him from the PIO-1 / O/o The Tahsildar, Dharmapuri Mandal, Jagtial District, PIO-2 / O/o The Assistant Director, Mines and Geology Department, Jagtial, Jagtial District and PIO-3 / O/o The District Assistant Labor Officer, Jagtial, Jagtial District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 14-02-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

- 1) మీ కార్యాలయ పరిధిలోని ఒక్కొక్క గ్రామ పంచాయితీలోని ప్రతి చెరువు చిన్నిగ్లము, సర్వే నెంబర్, వివరాలు, 1956 సంవత్సరానికి సంబంధించిన పహాణీలతో కూడిన సమాచారము ఇప్పించగలరు.
- 2) ఒకటవ అంశమునకు సంబంధించిన చెరువుల యొక్క నహాణీలు, 1956, 1966, 1986, 1996, 2006, 2010, 2019 సంవత్సరాలకు సంబంధించిన పహాణీల జిరాక్స్ కాపీలతో కూడిన సమాచారము విభిన్న పూర్వకముగా వ్రాసి యిప్పించగలరు.
- 3) మీ కార్యాలయ పరిధిలోని పి.ఐ.ఓ., అర్.డి.ఐ. శిక్షకు వెల్లిన తేదిల వివరాలు, సెల్ నెంబర్లతో కూడిన సమాచారము, మరియు రైతు బంధు ద్వారా మీరు ఎంత మంది రైతులకు రూపాయలు (చెక్కులు) యిచ్చారు. అట్టి రైతుల పేర్లు, వివరాల సమాచారము ఇప్పించగలరు.
- 4) సమాచార హక్కు చట్టము 2005 ప్రకారము సెక్షన్స్ 6(1), 6(3), 7(1), 8(ఎఫ్), 8(2) అనగా నేను వీటికి సంబంధించిన పూర్తి సమాచారము ఇప్పించగలరు.
- 5) మీ కార్యాలయ పరిధిలోని చెరువు శిఖం భూములు ఎన్ని ఎకరములు ఎన్క్రోచ్మెంట్ అయినవి. ఎవరిపైన మీరు ఏదైనా చర్యలు తీసుకున్నారా. తీసుకున్నట్లు అయితే అట్టి వివరాల సమాచారము ఇప్పించగలరు.
- 6) మీ కార్యాలయ పరిధిలో క్వార్టీలు, క్రషర్స్, ఇసుక, రీసులు, మట్టి ఇటుక బట్టీలు, ఇటుకల తయారీదానులు, మీ వద్ద అనుమతి పొందిన వారి వివరాలు, అనుమతి లేకుండా అక్రమంగా వ్యాపారము చేయుచున్న వివరాలు, స్టాండ్ ట్యాక్సీకి అనుమతులు ఇచ్చిన ట్రాక్టర్ల యొక్క నెంబర్లు, ఓనర్ పేరు, సెల్ నెంబర్, సమయము, కాలపరిమితి, అట్టి యజమానులు ఐ.డి. రిటర్న్లతో కూడిన పూర్తి సమాచారము ఇప్పించగలరు.

The Public Information Officer / O/o The Tahsildar, Dharmapuri Mandal, Jagtial District vide Memo. No. C/204/2019 dated 01-03-2019, has transferred the application U/s.6(3) of the RTI Act to the Public Information Officer / O/o The Assistant Director, Mines and Geology Department, Jagtial, Jagtial District and to the Public Information Officer / O/o The District Assistant Labor Officer, Jagtial, Jagtial District to furnish the information directly to the complainant under intimation to their office.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 09-12-2020.

P.T.O

The case is called on 09-12-2020. The Complainant is absent. The Public Information Officer-1 / Sri M. A. Shadab Hakeem, Naib Tahsildar, O/o The Tahsildar, Dharmapuri Mandal, Jagtial District is present. The Public Information Officer-2 / O/o The Assistant Director, Mines & Geology Department, Jagtial, Jagtial District is absent. The Public Information Officer-3 / Sri R. Krishna Sagar, Assistant Labour Officer, O/o The District Assistant Labour Officer, Jagtial, Jagtial District is present.

The Public Information Officer-1 submitted that the appellant is seeking information on six points. He also submitted that vide letter No. C/204/2019 dated 10-03-2019, available and held information was furnished to the complainant through RPAD. He further submitted that for remaining information the application was transferred U/s.6(3) of the RTI Act to the Public Information Officer / O/o The Assistant Director, Mines & Geology Department, Jagtial, Jagtial District and the Public Information Officer / O/o The District Assistant Labour Officer, Jagtial, Jagtial District Assistant vide letter Memo. No. C/204/2019 dated 01-03-2019, for furnishing the information.

The Public Information Officer-3 submitted that he has joined recently as Assistant Labour Officer, Jagtial and he was unaware of this RTI application, after receiving notice from the Telangana State Information Commission, the information was gathered and furnished to the appellant vide letter No. 62/2020 dated 08-12-2020.

As available information was furnished by both the Public Information Officers, the Commission keeping in view of Government of India instructions contained in O.M. No. 10/2/2008-IR, Ministry of Personal P.G. & Pensions, Department of P & T, New Delhi (copy attached) directs the complainant to file separate applications U/s. 6(1) with the Public Information Officer / O/o The Assistant Director, Mines, and Public Information Officer / O/o The Assistant Director, Agriculture seeking required information.

With the above direction, the complaints are closed.
