ORDER

Sri M. Ramakrishna, Peddapally District-505184 has filed 2nd appeal dated NIL which was received by this Commission on 06-04-2019 for not getting the information sought by him from the PIO / O/o The Tahsildar, Manthani Mandal, Peddapally District and 1st Appellate Authority / O/o The Tahsildar, Manthani Mandal, Peddapally District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 26-12-2018 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

Kindly provide the following information from the records of the Tahsildar's office Manthani as per RTI Act

- 1) letter mentioning the sanctioned amount by the concerned authority towards election expenses of state legislative assembly.
- 2) Each of the receipts of the amount incurred towards election expenses by the the Tahsildar's office, Manthani and submitted to the DIO, peddapally ..

Kindly allow inspection of material before issuing the sought information for selection of material.

I am submitting Rs.10, by way of judicial stamps towards requisite amount and assure you of additional amount.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 11-02-2019 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant

As the appellant did not get the information from the Public Information Officer and non response from the 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 02-11-2020.
