## ORDER

Sri Kalangi Hari Krishna, Bhadradri Kothagudem District-507101 has filed 2<sup>nd</sup> appeal dated 03-04-2019 which was received by this Commission on 08-04-2019 for not getting the information sought by him from the PIO / O/o The District Educational Officer, Bhadradri Kothagudem, Bhadradri Kothagudem District and 1<sup>st</sup> Appellate Authority / O/o The District Educational Officer, Bhadradri Kothagudem, Bhadradri Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 16-11-2018 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer has furnished the information to the appellant vide letter Rc. No. 4759/A2/RTI/2018 dated 04-12-2018 and vide letter No. 4759/B8/TSS/2018 dated 04-02-2019.

The appellant having not satisfied with the information received from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 25-02-2019 before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

P.T.O

The 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before appellant.

The appellant having not satisfied with the information received from the Public Information Officer and non response from the 1<sup>st</sup> Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 20-11-2020.

The case is called on 20-11-2020. The Appellant is absent. The Public Information Officer / O/o The District Educational Officer, Bhadradi Kothagudem, Bhadradi Kothagudem District is absent. Sri B. Mahesh Kumar, Junior Assistant is present on behalf of the Public Information Officer. The First Appellate Authority / O/o The District Educational Officer, Bhadradi Kothagudem, Bhadradi Kothagudem District is absent.

The representative of the Public Information Officer submitted that vide letter Rc. No. 4759/B8/TSS/2018 dated 20-12-2018 the sought information was furnished to the appellant under proper acknowledgment, whereas it is observed that the appellant filed this 2<sup>nd</sup> appeal on 08-04-2019 claiming that he has not received any information.

In view of above the Public Information Officer is hereby directed to furnish the information once again to the appellant within a week's time from the date of receipt of this order by RPAD and to report compliance.

With the above direction, the appeal is closed.
