ORDER

Sri Mohd. Ather Nawab, Hyderabad-500005 has filed a Complaint dated 13-04-2019 which was received by this Commission on 15-04-2019 for not getting the information sought by him from the PIO / O/o The Forest Range Officer, Narsampet Mandal, Warangal Rural District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 06-03-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

*Sub:- Application for providing information under RTI Act 2005
Sec 6(1) Req-Req,*

*① Please provide duly attested copy of Action Taken Report
on this Rc.No. 7873/2005/TG/WLR-1, Dt:- 31/12/2018, from
P.C.&F, Aranya Bhavan, HYD, T.S.
(copy enclosed Rc.No. 7873/2005/TG/WLR-1, Dt:- 31/12/2018).*

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 03-11-2020.

The case is called on 03-11-2020. The Complainant is absent. The Public Information Officer / O/o The Forest Range Officer, Narsampet Mandal, Warangal Rural District is absent.

Both the parties are absent.

A perusal of case record goes to show that the complainant filed 6(1) application on 06-03-2019 before the Public Information Officer / O/o The Forest Range Officer, Narsampet Mandal, Warangal Rural District seeking attested copy of action taken report on Rc. No. 7873/2005/TG/WLR-1, dated 31-12-2018 issued by Principal Chief Conservator of Forests, Aranya Bhavan, Hyderabad.

The record also goes to show that the Public Information Officer vide letter dated 30-11-2019 has informed the Commission that sought information was furnished to the complainant by RPAD on 22-05-2019 and produced postal proof.

The Commission directs the Public Information Officer to furnish the sought information once again to the complainant by RPAD within one week from the date of receipt of this order and to report compliance to the Commission.

With the above direction, the complaint is closed.
