ORDER

Sri Ayaz Ahmed, Ranga Reddy District has filed a Complaint dated 15-04-2019 which was received by this Commission on 16-04-2019 for not getting the information sought by him from the PIO / O/o The District Forest Officer (Ranga Reddy District), Aranya Bhavan, Saifabad, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 19-03-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

**Sub: Request to Furnish the Document No.1903/2017/S6,
Dt. 25-07-2017, Under RTI Act, 2005 U/S 6, Req – Reg.**

I, Ayaz Ahmed S/o Syed Iqbal Ahmed Muneer, Aged about 33 years, R/o Plot NO. 187/A, Musk Mahal, Rajendranagar Mandal, Ranga Reddy District, Telangana, do hereby solemnly submits that:

I submit that, I need "Certified Copies" of DFO. RR. Letter. No. 1903/2017/S6 Dt. 25-07-2017 of total file, for the purpose of record, to extract information required with respect of said records.

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 29-10-2020.

The case is called on 29-10-2020. The Complainant is absent. The Public Information Officer / Sri M. Srinivas, Superintendent, O/o The District Forest Officer (Ranga Reddy District), Aranya Bhavan, Saifabad, Hyderabad is present.

The Public Information Officer filed an affidavit and submitted that vide letter No. RTI/2019/S6, dated 16-05-2019 sought information was furnished to the complainant.

Since information was furnished, the complaint is closed.
