## **ORDER**

Smt Chinta Vijaya, Medchal District has filed a Complaint dated NIL which was received by this Commission on 18-04-2019 for not getting the information sought by her from the PIO / O/o The Tahsildar, Kapra Mandal, Medchal-Malkajiri District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 25-02-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in her application annexed.

1. I Chinta Vijaya, W/o: Late Shekar, Age: 38 Years, R/o. H.No: 23-52-24/217, Rajiv Gandhi Nagar, Jawahar Nagar GP, Kapra Mandla, Medchal District. Do here by seeking the follow mentioned information under section 6 of Right to information Act 2005
  - a. Is there any Community hall existed in RajeevGandi Nagar opposite to Army Dental College.
  - b. If so who allotted the land for community hall.
  - c. What is the survey no and extent of the community hall.
  - d. In which year the community hall was constructed.
  - e. What is the name of the contractor who constructed the community hall.
  - f. What is the construction cost of the community hall.
  - g. who allotted the funds for centurion of the community hall.
  - h. What is the date of opening ceremony of community hall and who are the government official presented in the opening ceremony.
  - i. How many rooms, fans, doors, windows, chairs, bathrooms were there.
  - j. Who is taking care of the day to day maintainence of community hall.
  - k. What is the bank account number of community hall
  - l. How many functions were performed in the community hall since from the opening to present date
  - m. How much amount was earned by community hall
  - n. How much amount was spent for maintenance per year.
  - o. What is the current meter no of community hall.
  - p. What is the number of water meter of community hall.

*I submit that furnish the details mentioned above along with the proceedings and supported documents.*

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing her application, she preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by her.

The Complaint was taken on file and the case is posted for hearing over phone on 24-08-2020.

Heard the case on 24-08-2020 over phone and adjourned to 26-11-2020 with a direction to the Public Information Officer to furnish complete information to the complainant within a week's time and to report compliance.

On 26-11-2020 the case is called. The Complainant is absent. The Public Information Officer / O/o The Tahsildar, Kapra Mandal, Medchal-Malkajgiri District is absent.

Both the parties are absent.

A perusal of 6(1) application goes to show that the complaint herein is seeking information on (16) points from the Public Information Officer. The record also discloses that the Public Information Officer has not furnished the sought information.

The Commission directs the Public Information Officer to furnish the sought information to the appellant within one week from the date of receipt of this order and to report compliance to the Commission, failing which action will be taken under the provisions of Sec. 20 of the RTI Act.

With the above direction, the appeal is closed.
