## **ORDER**

Sri Mohd. Ather Nawab, Hyderabad-500005 has filed a Complaint dated 16-04-2019 which was received by this Commission on 20-04-2019 for not getting the information sought by him from the PIO / O/o The Forest Range Officer, Narsampet Mandal, Warangal Rural District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 09-03-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

*Sub:- Application for providing information under RTI Act 2005, Sec 6(1) Reg-Reg, (6(1))*

- ① Please provide duly Attested copy of Guidelines follow By Forest Range officer, (F.R.O). Duties,*
- ② Please provide duly Attested copies of List forest land with survey numbers, <sup>villages,</sup> Total Acres, in forest Range officer limits.*
- ③ Please provide duly Attested copies of notices issued by you to illegal encroachers in forest land of Buddhraopet (V) from 2015 To Till my RTI Application.*
- ④ Please provide duly Attested copy of MAP Buddhraopet (V) of 2000 Acres sy- no 56/3 (old) with boundaries fix up of land.*
- ⑤ Please provide duly Attested copies of List cases Book By you on illegal encroachers of Buddhraopet (V) forest land from 2015 To Till my RTI Application.*

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 04-12-2020.

The case was called on 04-12-2020. The Complainant was present. The Public Information Officer / O/o The Forest Range Officer, Narsampet Mandal, Warangal Rural District was absent.

The Complainant submitted that he did not receive the sought information from the Public Information Officer.

As the Public Information Officer was not present to the hearing, the case was adjourned and next posted for hearing on 21-12-2020.

On 21-12-2020 the case is called. The Complainant is present. The Public Information Officer / Sri B. Mohan, Deputy Range Officer (FAC), O/o The Forest Range Officer, Narsampet Mandal, Warangal Rural District is present.

The Public Information Officer submitted that part information was furnished to the complainant on 04-12-2020 and filed an affidavit to this effect.

The Complainant submitted that he has not received information for point No. 3 and 4.

The Commission directed the Public Information Officer to furnish complete information for point Nos. 3 and 4 to the complainant, within one week from the date of receipt of this order and to report compliance to the Commission.

The Commission further warns the Public Information Officer to strictly follow the provisions of the RTI Act, by timely furnishing the information hereafter with reference to Sec. 7(1) of the RTI Act or otherwise action will be taken under the provisions of Sec. 20 of the RTI Act.

With the above direction, the complaint is closed.
