## **ORDER**

Sri Bochu Babu Rao, Warangal Rural District-506164 has filed 2<sup>nd</sup> appeal dated 04-06-2020 which was received by this Commission on 08-06-2020 for not getting the information sought by him from the PIO / O/o The Mandal Educational Officer, Parkal Mandal, Warangal Rural District-506164 and 1<sup>st</sup> Appellate Authority / O/o The Mandal Educational Officer, Parkal Mandal, Warangal Rural District-506164.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 27-02-2020 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

- 1) తిరుత్ ఘనం ఉన్నత పాఠశాలలలో ప్రైవేట్ అప్డేర్ ప్రైవేట్, ఉన్నత పాఠశాల ఉపాధ్యక్షులు వివరాలు. వారి అవినీతికేసు, టెంట్ అవినీతికేసు సర్టిఫికేట్స్ అటెస్టెడ్ డిటాక్స్ కావాలి.
- 2) టీచర్ల జీత భత్యం, P.F వివరాలు, P.F సంబంధం డిటాక్స్ కావాలి
- 3) సానిటేషన్, వెమికిత ఫీజుస్, ఫైర్ సేఫ్టీ సర్టిఫికేట్స్ డిటాక్స్
- 4) ప్లస్ ట్రాండ్, పారిశుధ్యం వివరాలు,
- 5) డెన్సిటీకా విద్యార్థులకు సర్టిఫికేట్స్ డిటాక్స్
- 6) 2019 - 20 ప్రైవేట్, అప్డేర్ ప్రైవేట్, ప్రాసూరక విద్యార్థుల (తరగతి వారీగా) వివరాలు
- 7) 2019 - 20 విద్యార్థుల (తరగతి వారీ) ఫీజుల వివరాల పట్టిక అటెస్టెడ్ డిటాక్స్
- 8) పాఠశాల ఇవనము సంతయం, అడ్మి వివరాలు డిటాక్స్ కావాలి

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 13-05-2020 before the 1<sup>st</sup> Appellate Authority / O/o The District Education Officer, Warangal Rural, Warangal Rural District u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1<sup>st</sup> Appellate Authority / O/o The District Education Officer, Warangal Rural, Warangal Rural District vide letter Rc. No. 892/B4/2020 dated 22-05-2020, has transferred the application U/s.6(3) of the RTI Act to the Public Information Officer / O/o The Mandal Educational Officer, Parkal Mandal, Warangal Rural District has furnish the information directly to the appellant under intimation to their office.

Since the appellant did not get the information from the Public Information Officer and 1<sup>st</sup> Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 20-11-2020.

The case is called on 20-11-2020. The Appellant is absent. The Public Information Officer / Smt. S. Ramadevi, Mandal Educational Officer (FAC), O/o The Mandal Educational Officer, Parkal Mandal, Warangal Rural District is present. The First Appellate Authority / O/o The Mandal Educational Officer, Parkal Mandal, Warangal Rural District is absent.

The Public Information Officer submitted that due to unforeseen reasons the sought information was not furnished and requested time for furnishing the information to the appellant.

The Commission allowed the Public Information Officer to furnish the sought information to the appellant within one week from the date of receipt of this order and to report compliance to the Commission.

The Commission warns the Public Information Officer that she should strictly follow the provisions of the RTI Act, by timely furnishing the information hereafter with reference to Sec. 7(1) of the RTI Act or otherwise action will be taken under the provisions of Sec. 20 of the RTI Act.

With the above direction, the appeal is closed.
