## **ORDER**

Sri Padmam Mahesh, Mahabubabad District-506104 has filed 2<sup>nd</sup> appeal dated 22-04-2019 which was received by this Commission on 24-04-2019 for not getting the information sought by him from the PIO / O/o The Forest Divisional Officer, Mahabubabad Mandal, Mahabubabad District and 1<sup>st</sup> Appellate Authority / O/o The Forest Divisional Officer, Mahabubabad Mandal, Mahabubabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 24-09-2018 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

- ① వసంత లింబర్ దివా ఫలకూచర్ వర్షు ఎప్పుడు రిజిస్ట్రేషన్ అయినది రిజిస్ట్రేషన్ కోరకు సమర్పించిన కాపీలు బీరాఫ్ ఇవ్వగలరు.
- ② వసంత లింబర్ దివా ఫలకూచర్ వర్షు రిజిస్ట్రేషన్ అయిన దగ్గరి నుండు ఇప్పటికే వరకు ఎన్ని చిట్-లు (త్రో) ఘోల్లు కేట వ దివా నుండు కొనుగోలు చిమము జరిగింది బీరాఫ్ కాపీలు ఇవ్వగలరు.
- ③ వసంత లింబర్ దివా ఫలకూచర్ వర్షు రిజిస్ట్రేషన్ అయిన దగ్గరి నుండు కొనుగోలు చిమము కేట వ రూపంగా అమ్మడం జరిగింది, ఎవరికి అమ్మడం జరిగింది మరియు ఏ చిమలగా అమ్మడం జరిగింది కిమియేటర్? Xerox copies ఇవ్వగలరు.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 11-02-2019 before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1<sup>st</sup> Appellate Authority has not responded to the appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 03-11-2020 and on 16-12-2020.

The case was lastly heard on 03-11-2020 by issuing notices to both the parties, both the parties found absent and the case was adjourned and next called on 16-12-2020 by issuing prior notices to both the parties.

On 16-12-2020 the case is called. The Appellant is absent. The Public Information Officer / O/o The Forest Divisional Officer, Mahabubabad Mandal, Mahabubabad District is absent. Sri G. Dwaliya, Forest Range Officer is present on behalf of the Public Information Officer. The First Appellate Authority / O/o The Forest Divisional Officer, Mahabubabad Mandal, Mahabubabad District is absent.

The representative of the Public Information Officer submitted that vide letter Rc. No. 46/2020-21/M dated 04-11-2020, sought information was furnished to the appellant by hand under proper acknowledgment.

The Commission directs the Public Information Officer to update 4(1)(b) information covering (17) points and to display the details of Public Information Officer and First Appellate Authority.

With the above direction, the appeal is closed.
