## **ORDER**

Sri Peddi Prabhakar Reddy, Karimnagar District-505001 has filed 2<sup>nd</sup> appeal dated 22-04-2019 which was received by this Commission on 26-04-2019 for not getting the information sought by him from the PIO / O/o The Tahsildar, Kodimial Mandal, Jagtial District and 1<sup>st</sup> Appellate Authority / O/o The Revenue Divisional Officer, Jagtial Division, Jagtial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 31-01-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

### **INFORMATION REQUESTED**

I request the honorable to provide certified copies of following information .

- A) Tahsildar office issued proceeding no: **B/1171/2018** for corrections in 1<sup>st</sup> stage LRUP to me i.e Peddi Prabhakar Reddy.
- B) Details of land extent in survey no's 857, 859, 860 and 861 respectively.
- C) Details of total land acquired by government from survey no's 857, 859, 860 and 861 for Project in 2008 and 2010.
- D) Grievance Document submitted in prajavani, Jagtial with prajavani no **.JG081/E/2018/00068** Dt-18/06/2018.
- E) Details of Number of members in survey no's 857, 859, 860 and 861 got PPB issued (Details are requested from signatures taken in registry when PPB is handed to members).

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 07-03-2019 before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 09-12-2020.

The case is called on 09-12-2020. The Appellant is present. The Public Information Officer / Sri M. Sammaiah, Naib Tahsildar, O/o The Tahsildar, Kodimial Mandal, Jagtial District is present. The First Appellate Authority / O/o The Revenue Divisional Officer, Jagtial Division, Jagtial District is absent.

Both the parties are present.

The Public Information Officer submitted that the sought information furnished to the appellant in presence of Commission. He also submitted that both online and manual pahanies were furnished to the appellant. It is further submitted that due to ban of Dharani website the corrections requested by the appellant were unable to complete.

The Appellant after going through the information furnished, submitted that he has received incomplete information from the Public Information Officer.

The Commission directed the Public Information Officer to re-verify the records and to furnish complete information to the appellant free of cost U/s. 7(6) of the Act within two weeks from the date of receipt of this order and to report compliance to the Commission.

With the above direction, the appeal is closed.
