ORDER

Sri Maddipadige Peddi Reddy, Jagtial District-505455 has filed a Complaint dated 18-02-2019 which was received by the Commission on 20-02-2019 and also filed 2nd appeal dated 25-04-2019 which was received by this Commission on 29-04-2019 for not getting the information sought by him from the PIO / O/o The Tahsildar, Jagtial Urban Mandal, Jagtial District and 1st Appellate Authority / O/o The Revenue Divisional Officer, Jagtial Division, Jagtial District.

The brief facts of the case as per the complaint and appeal and other records received along with it are that the appellant herein filed an application dated 18-08-2018 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 09-11-2018 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this Complaint before this Commission u/s 18(1) and 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 09-12-2020.

The case is called on 09-12-2020. The Appellant is absent. The Public Information Officer / Sri S. Sudheer, Deputy Tahsildar, O/o The Tahsildar, Jagtial Urban Mandal, Jagtial District is present.

The Public Information Officer submitted that the appellant is seeking information as to what action has been taken on the letter N.Dis. No. B/987/2018 dated 13-07-2018 which was received from the Revenue Divisional Officer, Jagtial Division, Jagtial District. The Public Information Officer submitted that he has furnished the sought information to the appellant vide letter No. B/775/2020 dated 08-12-2020 and produced a copy of the same before the Commission.

The Commission verified the material papers available on record and found that the Public Information Officer not furnished proper reply to the appellant as to what action taken by him on the Revenue Divisional Officer letter referred to above.

The Commission directs the Public Information Officer to furnish clear and correct information to the appellant within two weeks from the date of receipt of this order and to report compliance to the Commission.

The Commission warns the Public Information Officer if he failed to disobey the orders of the Commission, further action will be taken against him under the provisions of Sec. 20 of the RTI Act, 2005.

With the above direction, the appeals are closed.
