ORDER

Sri Cherla Anand Kumar, Rajanna Siricilla District-505302 has filed a Complaint dated 07-05-2019 which was received by this Commission on 08-05-2019 for not getting the information sought by him from the PIO / O/o The Municipal Council, Vemulawada Municipality, Rajanna Siricilla District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 08-03-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

The Public Information Officer has furnished the information to the complainant vide letter No. G1/20/2018-69 dated 08-04-2019.

The Complainant having not satisfied with the information received from the PIO, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 16-12-2020.

The case is called on 16-12-2020. The Complainant is present. The Public Information Officer / Sri A. Anjaneyulu, Town Planning Officer, O/o The Municipal Council, Vemulawada Municipality, Rajanna Siricilla District is present.

The Complainant submitted that he did not receive the sought information from the Public Information Officer.

The Public Information Officer submitted that vide RTI letter No. G1/20/2018/69 dated 08-04-2019, sought information was furnished to the complainant which was dispatched through RPAD on 16-04-2019.

As the complainant claims that he did not receive the sought information. The Commission directed the Public Information Officer to furnish complete information once again to the complainant within one week from the date of receipt of this order and to report compliance to the Commission. The Commission also directed the Public Information Officer to strictly follow the provisions of the RTI Act, by timely furnishing the information hereafter with reference to Sec. 7(1) of the RTI Act or otherwise action will be taken under the provisions of Sec. 20 of the RTI Act.

With the above direction, the complaint is closed.
