## **ORDER**

Sri Lega Karunakar Reddy, Jangaon District has filed a Complaint dated 08-05-2019 which was received by this Commission on 09-05-2019 for not getting the information sought by him from the PIO / O/o The Gram Panchayat Secretary, Neermala Village, Devaruppula Mandal, Jangaon District-506303.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 04-04-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

సర్వే నెం. 15/1, వీరబ్రహ్మేశ్వరం పరిధిలోని ఇల్లు నిర్మాణముకు అనుమతి పత్రమును మరియు విద్యుత్ సౌకర్యమును అనుమతి పత్రము మరియు నెట్ వర్క్ సౌకర్యమును సమాచార హక్కు చట్టం క్రింద మొక్క సంఖ్య ద్వారా గుర్తించుట.

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 24-11-2020.

The case is called on 24-11-2020. The Complainant is absent. The Public Information Officer / O/o The Gram Panchayat Secretary, Neermala Village, Devaruppula Mandal, Jangaon District is absent.

Both the parties are absent.

A perusal of case record goes to show that the complainant filed 6(1) application before the Public Information Officer / O/o The Gram Panchayat Secretary, Neermala Village, Devaruppula Mandal, Jangaon District. The case record unfolds that the Public Information Officer has not furnished the sought information.

The Commission directs the Public Information Officer to furnish the sought information to the complainant, within one week from the date of receipt of this order and to report compliance to the Commission.

With the above direction, the complaint is closed.
