ORDER

Sri P. Rajendra Prasad, Hyderabad-500092 has filed 2nd appeal dated 30-12-2019 which was received by this Commission on 02-01-2020 for not getting the information sought by him from the PIO / O/o The District Educational Officer, Hunter Road, Near District Court, Postal Colony, Subedari, Hanamkonda, Warangal Urban District-506001 and 1st Appellate Authority / O/o The District Educational Officer, Hunter Road, Near District Court, Postal Colony, Subedari, Hanamkonda, Warangal Urban District-506001.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 24-10-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

1.DSC 2008 Warangal PET Total Information like vacant reservation Details and Reservation Deatalls Notification Details caste wise Details and Total information need

2.P.Rajendra prasad s/o achalaih h no 2-83,ghanpur ,warangal -506144, DSC 2008 PET Speed post ack copy RC.NO.817/RC-3/2009-10 Date:26.03.2014 copy need

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 27-11-2019 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 18-11-2020.

The case is called on 18-11-2020. The Appellant is absent. The Public Information Officer / O/o The District Educational Officer, Hunter Road, Near District Court, Postal Colony, Subedari, Hanamkonda, Warangal Urban District is absent. The First Appellate Authority / O/o The District Educational Officer, Hunter Road, Near District Court, Postal Colony, Subedari, Hanamkonda, Warangal Urban District is absent.

P.T.O

Both the parties are absent.

A perusal of 6(1) application goes to show that the appellant herein is seeking the information with on (2) points from the Public Information Officer. The record also discloses that having not received the information within stipulated time, he preferred the first appeal before the First Appellate Authority on 27-11-2019. The case record unfolds that the Public Information Officer has not furnished the sought information.

The Commission observed that on receipt of preliminary notice sent by Telangana State Information Commission dated 07-01-2020, the Public Information Officer vide letter No. 1120/B1/RTI/2020 dated 02-03-2020, has furnished the available and held information to the appellant.

The Commission directs the Public Information Officer to re-verify and to furnish complete information to the appellant once again within one week from the date of receipt of this order and to report compliance to the Commission.

The Commission further warns the Public Information Officer to strictly follow the provisions of the RTI Act, by timely furnishing the information hereafter with reference to Sec. 7(1) of the RTI Act or otherwise action will be taken under the provisions of Sec. 20 of the RTI Act.

With the above direction, the appeal is closed.
