ORDER

Sri B. Shivananda Murthy, Jangaon District-506252 has filed 2nd appeal dated 22-05-2019 which was received by this Commission on 24-05-2019 for not getting the information sought by him from the PIO / O/o The Tahsildar, Duggondi Mandal, Warangal Rural District and 1st Appellate Authority / O/o The Revenue Divisional Officer, Narsampet Division, Warangal Rural District-506132.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 18-03-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer vide Memo. Rc. No. B/463/2019, dated 27-03-2019 has furnished the information to the appellant.

The appellant was not satisfied with the information received from the Public Information Officer, he filed 1st appeal dated 23-04-2019 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority vide Notice Rc. No. C/111/2018, dated 30-04-2019 has informed the appellant and the Public Information Officer / O/o The Tahsildar, Duggondi Mandal, Warangal Rural District to appear before their office for hearing on 04-05-2019 at 11:00 AM along with relevant documents, the subsequent orders passed thereon is not known.

As the appellant was not satisfied with the information received from the Public Information Officer and 1st Appellate Authority, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and the case was posted for hearing over phone on 02-09-2020.

On overview spread of COVID-19, the case was last heard over phone on 02-09-2020. The Appellant and the Public Information Officer were heard.

The Appellant submitted that he had received incomplete information from the Public Information Officer. He also submitted that in respect of survey No. 201/B patta was not issued.

The Public Information Officer submitted that he has furnished the sought information to the appellant vide letter Memo. Rc. No. B/463/2019 dated 27-03-2019.

The case was adjourned and posted on 11-11-2020.

On 11-11-2020 case is called. The Appellant is present. The Public Information Officer / O/o The Tahsildar, Duggondi Mandal, Warangal Rural District is absent. The Assistant Public Information Officer / Sri V. Balaji, Senior Assistant is present on behalf of the Public Information Officer. The First Appellate Authority / O/o The Revenue Divisional Officer, Narsampet Division, Warangal Rural District is absent.

The Appellant submitted that he was not satisfied with the information received from the Public Information Officer. He also submitted that for point No. 5 complete information was not furnished.

The Assistant Public Information Officer submitted that vide letter Memo. Rc. No. B/463/2019 dated 27-03-2019 sought information was furnished to the appellant.

Heard both the parties and perused the material papers available on record. The Commission observed that the Public Information Officer has not furnished the complete information for Point No. 5.

The Commission directs the Public Information Officer to furnish the complete information to the appellant within one week from the date of receipt of this order and to report compliance to the Commission.

With the above direction, the appeal is closed.

Issue Show Cause Notice to the Public Information Officer for not furnishing complete information to the appellant and for not appearing in person before the Commission on the date of hearing.
