## ORDER

Sri Mohd. Ather Nawab, Hyderabad-500005 has filed a Complaint dated 27-05-2019 which was received by this Commission on 27-05-2019 for not getting the information sought by him from the PIO / O/o The Tahsildar, Khanapur Mandal, Warangal Rural District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 05-04-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

*Sub: - Application for providing information under RTI Act 2005, Sec 6(1) Reg-Reg.*

- ① Please provide duly Attested copie 1 B<sup>n</sup> of Budharaopet village in sy-no 3/1 and 3/2, from 1990 To Till my Rti Application.*
- ② Please provide duly Attested copies 13 B, and 12 c, documents of Budharaopet village in sy-no 3/1 and 3/2 from 1990 To Till my Rti Application.*

The Public Information Officer vide Memo. Rc. No. B/350/2019, dated 15-04-2019 has informed the complainant that the information sought for containing total (109) pages and requested the complainant to pay Rs. 545/- to obtain the information.

The Complainant having not received the required information from the PIO even after paying the charges for Rs. 545/- on 30-04-2019, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and the case was posted for hearing over phone on 03-09-2020.

On overview spread of COVID-19, the case was last heard over phone on 03-09-2020. The Complainant and the Public Information Officer were heard.

The Public Information Officer submitted that vide Memo. Rc. No. B/350/2019, dated 04-05-2019 information was furnished to the complainant through RPAD.

The Complainant submitted that he did not receive the sought information from the Public Information Officer.

Heard both the parties and perused the material papers available on record. The Commission observed that the Public Information Officer vide letter No. B/350/2019 dated 15-04-2019 sought payment of Rs. 545/- for furnishing information, and the same was paid. He has furnished copy of 1(B) Register of Budharaopet Village. But it is claimed by the complainant that no information was furnished.

**The case was adjourned to 11-11-2020.**
