ORDER

Sri M. Shyam Sunder, Peddapally District-505184 has filed a Complaint dated 01-04-2019 which was received by this Commission on 27-05-2019 for not getting the information sought by him from the PIO / O/o The Regional Joint Director of School Education, Hanamkonda, Warangal Urban District-506001.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 11-02-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 18-11-2020.

The case is called on 18-11-2020. The Complainant is absent. The Public Information Officer / Smt. M. Vanitha, Assistant Director, O/o The Regional Joint Director of School Education, Hanamkonda, Warangal Urban District is present.

The Public Information Officer submitted that vide letter Rc. No. 932/B3/A4/RTI/2019 dated 07-05-2019 the District Education Officer, Rajanna Siricilla was instructed to provide the desired information to the complainant.

Heard the Public Information Officer and perused the material papers available on record. The Commission observed that there is nothing on record to show that the Public Information Officer has furnished the sought information to the appellant.

The Commission directs the Public Information Officer to examine the plea made by the complainant in his application filed U/s. 6(1) of the Act and to furnish the information to the complainant within one week from the date of receipt of this order and to report compliance to the Commission.

The Commission also warns the Public Information Officer to strictly follow the provisions of the RTI Act, by timely furnishing the information hereafter with reference to Sec. 7(1) of the RTI Act or otherwise action will be taken under the provisions of Sec. 20 of the RTI Act.

With the above direction, the complaint is closed.
