ORDER

Sri Mahankali Prakash, Medchal-Malkajgiri District has filed a Complaint dated 17-06-2019 which was received by this Commission on 17-06-2019 for not getting the information sought by him from the PIO-1 / O/o The Tahsildar, Keesara Mandal, Medchal-Malkajgiri District and PIO-2 / O/o The Assistant Director, Survey and Land Records, Medchal-Malkajgiri District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 22-01-2018 before the PIO / O/o The Collector and District Magistrate, Medchal District under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

The Public Information Officer / Inspector of Survey, Survey and Land Records, Medchal-Malkajgiri District vide letter No. K3/241/2019 dated 20-03-2019, has transferred the application U/s. 6(3) to the Public Information Officer / O/o The Tahsildar, Keesara Mandal, Medchal-Malkajgiri District for taking necessary action as per rules admissible under RTI Act, 2005.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 18-12-2020.

The case is called on 18-12-2020. The Complainant is absent. The Public Information Officer-1 / Smt. B. Prasanna Laxmi, Naib Tahsildar, O/o The Tahsildar, Keesara Mandal, Medchal-Malkajgiri District is present. The Public Information Officer-2 / Sri M. Ramchander, Assistant Director, O/o The Assistant Director, Survey and Land Records, Medchal-Malkajgiri District is present.

The Public Information Officer / O/o The Assistant Director, Survey and Land Records, Medchal-Malkajgiri District submitted that they have transferred the application received U/s. 6(1) of the RTI Act to the Public Information Officer / O/o The Tahsildar, Keesara Mandal, Medchal-Malkajgiri District vide letter No. K3/241/2019 dated 20-03-2019 on the point of jurisdiction.

After verifying the material papers available on record, it is found by the Commission that the Public Information Officer / O/o The Tahsildar, Keesara Mandal, Medchal-Malkajgiri District failed to furnish the information to the complainant.

The Commission thereby directs the Public Information Officer / O/o The Tahsildar, Keesara Mandal, Medchal-Malkajgiri District to furnish the information the complainant within a week's time from the date of receipt of this order and to report compliance to the Commission, that failing to which the Public Information Officer has to face further action U/s.20 of the RTI Act, 2005.

With the above direction, the complaint is closed.
