ORDER

Sri Vuyyala Anjaneyulu, Karimnagar District has filed a Complaint dated NIL which was received by this Commission on 19-06-2019 for not getting the information sought by him from the PIO / O/o The Municipal Commissioner, Siricilla Municipality, Rajanna Siricilla District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 27-03-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

Sub: Request for the copy of Proposal Layout at Sainagar in S.Y.No: 729/A, 729/B Under R.T.I act section no: 6/2005.

I, Vuyyala Anjaneyulu and S/o Lingalakshy other residents of Siricilla request you for the copy of Proposal Layout at Sainagar in S.Y.No: 729/A, 729/B which had submitted in the year 7/05/2000 at Siricilla Municipality. All copies which are related to the Proposal Layout of S.Y.No: 729/A, 729/B at Sainagar, Siricilla are needed due to some reasons. Please kindly accept my request for the issue of copies of above proposal layout file under R.T.I act section no: 6/2005. Please kindly respond to my request as soon as possible.

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 27-11-2020.

The case is called on 27-11-2020. The Complainant is absent. The Public Information Officer / Sri K. Vijay Kumar, Manager, O/o The Municipal Commissioner, Siricilla Municipality, Rajanna Siricilla District is present.

The Public Information Officer submitted that vide letter File No. G1/RTI/114/3553/2019 dated 22-04-2019, sought information was furnished to the complainant.

The Commission observed that the Public Information Officer has not produced clear copy of plan. The Commission directed the Public Information Officer to furnish clear copy of plan to the complainant once again, within one week from the date of receipt of this order and to report compliance to the Commission.

With the above direction, the complaint is closed.
