ORDER

Sri Dongiri Bakkaiah, Mulugu District-506165 has filed a Complaint dated 28-06-2019 which was received by this Commission on 01-07-2019 for not getting the information sought by him from the PIO / O/o The Mandal Parishad Development Officer, Eturnagaram Mandal, Mulugu District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 23-05-2019 before the PIO / The District Revenue Officer, O/o The Collector and District Magistrate, Mulugu, Mulugu District under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

Handwritten notes in Telugu script, including a large blue watermark 'SIC'. The text includes dates like 10/5/2019 and 15/5/2019, and various alphanumeric codes such as AP 36-TB-2226, TS-03-UB-5578, and TS-25-T-0912. It also mentions 'VOTER LIST' and 'MULUGU DISTRICT COLLECTOR'. The notes are organized into sections with circled numbers 1, 2, and 3.

The Public Information Officer / The District Revenue Officer, O/o The Collector and District Magistrate, Mulugu, Mulugu District vide letter Rc. No. A/619/2019 dated 03-06-2019, has forwarded the application to the Public Information Officer / O/o The Mandal Parishad Development Officer, Eturnagaram Mandal, Mulugu District to furnish the action taken report to their office and the same was copy marked to the complainant.

As the Complainant did not receive the required information from the PIO, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 18-12-2020.

The case is called on 18-12-2020. The Complainant is absent. The Public Information Officer / Smt. B. Uma Rani, Superintendent, O/o The Mandal Parishad Development Officer, Eturnagaram Mandal, Mulugu District is present.

The Public Information Officer submitted that the required information is furnished vide letter dated 19-06-2020, but he failed to provide a copy of the same with acknowledgment to the Commission.

The Commission thereby directs the Public Information Officer to furnish a reply thereof once again to the complainant by registered post acknowledgment due within a week's time from the date of receipt of this order and to report compliance, failing which the Commission will take further action against the Public Information Officer under the provisions of Sec.20 of the RTI Act, 2005.

With the above direction, the complaint is closed.
