## ORDER

Sri Mohd. Ather Nawab, Hyderabad-500005 has filed a Complaint dated 17-07-2019 which was received by this Commission on 17-07-2019 for not getting the information sought by him from the PIO / O/o The Telangana State Archives and Research Institute, Tarnaka, Hyderabad-500017.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 17-06-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

① Please provide Duly Attested copies of entire file NO:- 75/2, fasli :- 1330, of Nacharam, Related to — Maharaja Kishan Prashad, and Muttawa Syed Hussain Avadhi Awal taluqdar Nawaz Yar Jung.

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 15-12-2020.

The case is called on 15-12-2020. The Complainant is present. The Public Information Officer / Sri Mohd. Abdul Raqeeb, Assistant Director, O/o The Telangana State Archives and Research Institute, Tarnaka, Hyderabad is present.

The Complainant submitted that he did not receive the sought information from the Public Information Officer. He also requested the Commission for inspection of records.

The Public Information Officer submitted that a copy of letter was furnished to the complainant vide letter No. R1/2071/Sectt/2019 dated 15-07-2019 by post stating that the sought file is not available in their office.

The Commission directed the Public Information Officer to call the complainant to their office on 23-12-2020 for inspection of records to enable him to obtain available and held information and to report compliance to the Commission.

With the above direction, the complaint is closed.
