ORDER

Sri Parchaka Sampath, Jayashankar Bhupalpally District-506352 has filed 2nd appeal dated 17-01-2019 which was received by this Commission on 22-01-2019 for not getting the information sought by him from the PIO / O/o The Tahsildar, Mulugu Mandal, Jayashankar Bhupalpally District-506343 and 1st Appellate Authority / The District Revenue Officer, O/o The Collector and District Magistrate, Jayashankar Bhupalpally District-506169.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 28-09-2018 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

In light of the above description, kindly provide me the following information under section 2(f)(j) of the Act'2005:

- 1. Please provide copy of the title deed of the property behind the pond of "Ayyavarikunta" with year wise as per revenue land records.**
- 2. Please provide copy of necessary documents in support as per record:**
- 3. Please provide information pertaining to the name of the owners of the property behind the pond of "Ayyavarikunta" with year wise as per revenue land records.**

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 31-10-2018 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 04-11-2020.

The case is called on 04-11-2020. The Appellant is absent. The Public Information Officer / O/o The Tahsildar, Mulugu Mandal, Jayashankar Bhupalpally District is absent. Sri K. Surender Reddy, Junior Assistant is present on behalf of the Public Information Officer. The First Appellate Authority / The District Revenue Officer, O/o The Collector and District Magistrate, Jayashankar Bhupalpally District is absent.

The representative of the Public Information Officer submitted that vide letter Memo Rc. No. B/5184/2018 dated 01-02-2019, sought information was furnished to the appellant. He also submitted that their office has received a mail from the appellant stating that he was satisfied with the information received and a copy of mail was produced before the Commission.

Since information was furnished, the appeal is closed.
