ORDER

Sri Mohd. Habeebuddin, Hyderabad has filed a Complaint dated 22-07-2019 which was received by this Commission on 22-07-2019 for not getting the information sought by him from the PIO / O/o The Tahsildar, Quthubullapur Mandal, Medchal District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 16-05-2019 before the PIO / O/o The Collector, Medchal-Malkajgiri District under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

In my letter 1st cited above I have requested PIO Office of the Collector, Medchal, Malkajgiri District to provide me information regarding the land bearing Sy.Nos. 39, 39/ 39/ 40/1, 40/2, 40/3, 41, 42 situated at Pet Basheerabad Village Qutubullapur Mandal, Medchal District. In the above said survey numbers how much is Wakf and grave yard land, how many peoples have encroached the above said survey number land and to provide me the details of the land and name of encroachers.

Vide your letter 2nd cited above informed to me that my application has been transmitted the petition to PIO, O/O Tahsildar Qutubullapur Mandal, Medchal, Malkajgiri District and given instruction to provide me information directly through RPAD. But till date I have not received any information from the PIO O/o the Tahsildar, Quthbullapur Mandal.

Once again I remind your goodself to issue order or instructions to provide me the information as sought by me vide my application 1st cited above.

The Public Information Officer / O/o The Collector, Medchal-Malkajgiri District vide letter No. A3/RTI/154/2019 dated 22-05-2019 has requested the complainant to file an appeal before the concerned Revenue Divisional Officer, Malkajgiri Division, Medchal-Malkajgiri District U/s.19(1) of the RTI Act as the matter concerned with the O/o The Tahsildar, Quthubullapur Mandal, Medchal District.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 18-12-2020.

The case is called on 18-12-2020. The Complainant is absent. The Public Information Officer / O/o The Tahsildar, Quthubullapur Mandal, Medchal District is absent. Sri G. Balaraju, Village Revenue Officer is present on behalf of the Public Information Officer.

The representative of the Public Information Officer submitted that they have furnished complete information vide letter No. D/RTI/111/2020 dated 11-12-2020, and filed copies of the same before the Commission duly filing an affidavit to this effect.

As the information is furnished, the complaint is closed.
