ORDER

Dr. K. Chandra Sekharaiah, Hyderabad-500085 has filed 2nd appeal dated 05-08-2019 which was received by this Commission on 07-08-2019 for not getting the information sought by him from the PIO / O/o The Registrar, JNTU-Hyderabad, Kukatpally, Hyderabad and 1st Appellate Authority / O/o The Vice Chancellor, JNTU-Hyderabad, Kukatpally, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 20-04-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

Sir,

Under RTI Act 2005, please furnish the following information:
" ~~What is the~~ ^{particulars} selection criterion information for picking me up for transfer to JNTUHCENOM administrative grounds".
Please furnish the administrative ground selection criterion for picking me up for transfer.

The Public Information Officer has given a reply to the appellant vide letter No. JNTUH/RTI Cell/Rt:3381/2019 dated 06-05-2019.

The appellant having not satisfied with the reply received from the Public Information Officer, he filed 1st appeal dated 14-05-2019 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

The appellant having not satisfied with the reply received from the Public Information Officer and non response from the 1st Appellate Authority, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 21-12-2020.

The case is called on 21-12-2020. The Appellant is absent. The Public Information Officer / Prof. M. Manzoor Hussain, Registrar, O/o The Registrar, JNTU-Hyderabad, Kukatpally, Hyderabad is present. The First Appellate Authority / O/o The Vice Chancellor, JNTU-Hyderabad, Kukatpally, Hyderabad is absent.

The Public Information Officer submitted that vide letter No.JNTUH/RTI Cell/Rt:3381/2019 dated 06-05-2019 the appellant was informed that through proper channel information can be obtained.

The Commission is of the opinion that reply given by the Public Information Officer is not convincing. The Commission examined the plea of the appellant and found that the appellant has sought information viz. administrative ground selection for picking him up for transfer.

The Commission keeping in view of Sec.4(1)(d) of the RTI Act directs the Public Information Officer to furnish required information to the appellant within two weeks from the date of receipt of this order and to report compliance.

With the above direction, the appeal is closed.
