ORDER

Sri Mohd. Ather Nawab, Hyderabad-500005 has filed a Complaint dated 07-08-2019 which was received by this Commission on 07-08-2019 for not getting the information sought by him from the PIO / O/o The Tahsildar, Ghatkesar Mandal, Medchal District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 22-06-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

SUB:- Application for providing information under RTI ACT 2005, Sec 6(1) Reg-Reg.
① Please provide duly Attested copies of NOTICES, — Issued By your Mandal office To Entire Ghatkesar Mandal Land's Pattedar's Before issuing The P.P.B,

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and the case was posted for hearing over phone due spread of COVID-19 Pandemic on 03-09-2020 and next on 02-11-2020, duly issuing notices to both parties for personal appearance.

The case is called on 02-11-2020. The Complainant is absent. The Public Information Officer / Sri K. Ashwin Kumar, Naib Tahsildar, O/o The Tahsildar, Ghatkesar Mandal, Medchal District is present.

This case came up for hearing on 03-09-2020, the case was adjourned as the Public Information Officer has not furnished the sought furnishing to the complainant.

Today when the matter came up for hearing, the Public Information Officer is present and submitted that the information sought was huge and voluminous information. Thereby requested the complainant to visit their office for verification of records to seek specific information required by issuing endorsement No. C/RTI/6294/2020 dated 30-10-2020.

The Commission directed the Public Information Officer to call the complainant to their office for verification of records on mutually convenient date and time and to furnish the desired information to the complainant within two weeks from the date of receipt of this order.

The Commission further directs the Public Information Officer to strictly adhere to the provisions of the RTI Act, 2005 in furnishing information hereafter or otherwise action will be initiated U/s.20 of the RTI Act.

With the above directions, the complaint is closed.
