ORDER

Sri Mohd. Ather Nawab, Hyderabad-500005 has filed a Complaint dated 07-08-2019 which was received by this Commission on 07-08-2019 for not getting the information sought by him from the PIO / O/o The Tahsildar, Ghatkesar Mandal, Medchal-Malkajgiri District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 05-07-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

① Please provide duly attested copies of VIII A Notices issued by your office to illegal Land Possessor in - Khata No's :- 125, 111, and 112, which land belongs to Pattedar's 1) Syed Tahera Begum, 2) Syed Ali Ahmed - Hussain, as per Revenue Records of Mutawalguda Village.

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and the case is posted for hearing over phone on 19-08-2020 and on 16-12-2020 by issuing prior notices to both the parties.

The case was lastly heard on 19-08-2020 on overview spread of COVID-19, both the parties were heard and the case was adjourned and next called on 16-12-2020 by issuing prior notices to both the parties.

On 16-12-2020 the case is called. The Complainant is present. The Public Information Officer / Sri K. Ashwin Kumar, Naib Tahsildar, O/o The Tahsildar, Ghatkesar Mandal, Medchal-Malkajgiri District is present.

The Public Information Officer submitted that vide endorsement No. C/RTI/1483/2020 dated 16-12-2020, sought information was furnished to the complainant in presence of the Commission under proper acknowledgment.

The Complainant accepted the information and he was satisfied with the information received from the Public Information Officer.

In view of the above, the complaint is closed.
